

ORDINANCE NO. 18-03

AN ORDINANCE OF THE CITY OF PURCELL AMENDING CHAPTER 10 (ANIMALS); ARTICLE 1 (IN GENERAL), SECTION 10-1 (DEFINITIONS) BY ADDING THERETO DEFINITIONS FOR CHICKEN COOPS AND CHICKEN RUNS AND RENUMBERING THE BALANCE OF THE DEFINITIONS CONTAINED IN SECTION 10-1 AFTER INCLUSION OF THE ABOVE DEFINITIONS; AND AMENDING ARTICLE 2 (KEEPING: CONFINING ANIMALS), DIVISION 1 (GENERALLY), SECTION 10-33 (LIVESTOCK); PROVIDING FOR SEVERABILITY; AND PROVIDING FOR REPEALER

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PURCELL, OKLAHOMA AS FOLLOWS:

SECTION 1. SECTION 10-1. DEFINITIONS.

Chapter 10 (Animals), Article 1 (In General), Section 10-1 (Definitions) is amended by including a definition for chicken coop and chicken run therein as items number 6 and 7, to-wit:

- 6. *Chicken coop* means a small structure or enclosure where chickens nest, roost or perch and may include feeding and watering devices.**
- 7. *Chicken run* means an enclosed area physically connected to the coop where chickens are able to walk or run about which may include feeding and watering devices.**

SECTION 2. SECTION 10-33 LIVESTOCK.

Chapter 10 (Animals), Article 2 (Keeping: Confining Animals), Division 1 (Generally), is amended by striking the current Section 10-33 and replacing it with the following, to-wit:

It is unlawful to keep any livestock in the City, with the exception of those kept for FFA or 4-H projects on public school property, or as may be allowed in Chapter 122.

SECTION 3. RENUMBERING SUBSEQUENT DEFINITIONS.

All subsequent definitions in said Section 10-1 shall remain as is, shall maintain their current position but shall be renumbered so that the numbers remain in consecutive order.

SECTION 4. SEVERABILITY.

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is, for any reason, held invalid or unconstitutional by any Court of competent jurisdiction, said portion shall be deemed a separate, distinct and independent provision and such holding shall not affect the validity of the remaining portions of this Ordinance.

SECTION 5. REPEALER.

All ordinance or parts of ordinances in conflict herewith are hereby repealed.
